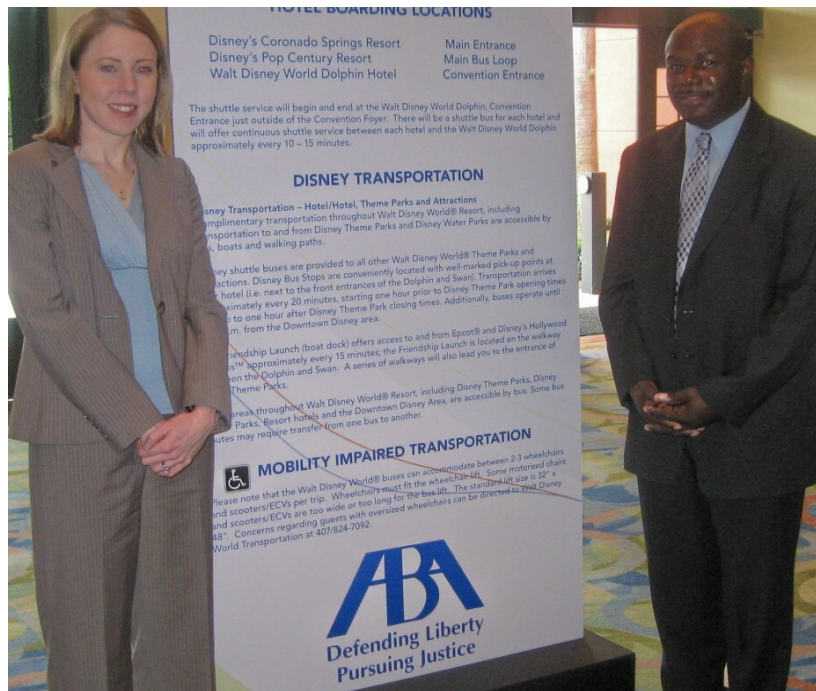

"The Changing Face of Discrimination: From Where We've Been to Where We're Going in Civil Rights Law", was the topic addressed by the panel which consisted of Gerald S. Hartman, Partner at Drinker & Biddle in Washington, D.C., Kathleen Liever, Associate at Fowler White Boggs in Tampa, Florida, and FCRA President, J. Willie David III,

The American Bar Association was interested in FCRA's view point and impact in the community as it relates to civil rights and discrimination, specifically as non lawyers. David who is a private investigator shared how his experience and expertise aided in successful litigation for victims as well as procedural and policy changes.

He provided a brief analysis of three (3) high profile cases investigated by the organization, which garnered significant media attention, community participation and policy changes. FCRA State Secretary Marsha Watson provided the history of the organization and FCRA Transportation Chairperson Henry Stowe presentation focused on the civil rights violations of the Red Light Ticket Cameras, which detailed statistical information from all over the United States and abroad and FCRA "Did you know" educational campaign. FCRA presentation focused on the increase in civil rights and discrimination as a result of policy, procedural and law violation by business and governmental agencies.

The presentation sparked interest from several attorneys addressing similar issues in Texas and Florida.

The Mid year meeting is known to match the volume of business transactions as the Annual Meeting and has established policy recommendation regarding the insanity defense, federal product liability legislation, Internal Revenue Code, judicial salaries, the United Nations Genocide Convention, Standards for Lawyer Discipline and Disability Proceedings, and the Model Code of Judicial Conduct.
